2      31-03-2026                      Heard learned counsel for the petitioner and learned counsel for the State.

2. The present writ petition has been filed for the following relief/s:-

*“I. That this writ petition is for issuance of the nature of Mandamus Commanding and directing to the respondent authority for the modify the designation of petitioner as (Pradhanlpik Sah lekha pal) to final and last*



*seniority list 2025 of Clerical Cadre is mentioned at Serial no. 5 As (Annexure -9) issued vide Memo No. 156 (de-chi) dated 30.01.2025, where is the correct name with designation has been published at Serial no. 5 on web side to provisional Seniority list for press release on 25.06.2024 vide Memo No. 632 Aa-chi). As such also directed to respondent authority to consider the recommended application vide letter no. 15 dated 04.02.25 by the official head for correction of last Seniority list 2025 as posting place of petitioner. Should not be obstructed from the post of Pradhan lipik Sah lekha pal (Head clerk Cum Accountant).*

*II. And grant of any appropriate relief and reliefs which the petitioner may be legally entitled to the facts and circumstances of the present case.”*

3. Learned counsel for the petitioner submits that for fulfillment of his grievance, he has filed representation before the Officer on Special Duty cum Director General (Ayush), Health Department, Bihar, Patna, but no decision has been taken.

4. Learned counsel for the State submits that there is no instruction about disposal of the petitioner's representation.



5. As such, the petitioner is directed to produce a copy of his representation as well as copy of this order before the Officer on Special Duty cum Director General (Ayush), Health Department, Bihar, Patna (Respondent no.5), within 30 days from today. The Respondent no.5 upon receiving the petitioner's representation is directed to pass order assigning reasons, within 90 days thereafter.

6. Accordingly, with the aforesaid direction, this writ petition stands disposed off.
