the petitioner and Mr. Tapeswar Sharma, learned Additional
Public Prosecutor for the State.

2. Petitioner seeks bail who is in custody since
28.07.2025 in connection with Sessions Trial No. 932 of 2025
arising out of Kumarbag P.S. Case No. 145 of 2025, F.I.R. dated
27.07.2025 for the offences punishable under Sections 103(1),
80 and 3(5) of the BNS, 2023.

3. According to prosecution case, this petitioner along
with other accused persons have killed the daughter of the
informant over non-fulfillment of demand of Rs. 3 lakhs.

4. Learned counsel for the petitioner submits that
petitioner has clean antecedent and he has falsely been
implicated in the present case. He has been made accused



merely on the ground that he is husband of the deceased. The allegation as alleged in the FIR is false and fabricated and the petitioner has not committed any offence as alleged in the FIR.

5. The learned Additional Public Prosecutor on the basis of material available on record and the case diary has vehemently opposed the prayer for bail of the petitioner and submits that it appears from the record of the case diary that the marriage of the petitioner was solemnized on 18.04.2025 and the alleged occurrence took place on 26.07.2025 i.e, within a period of three months. Apart from that it appears from the postmortem report that number of ante-mortem injuries were found on the body of the deceased.

6. Considering the aforesaid facts and circumstances of the case, I am not inclined to enlarge the petitioner on bail in connection with Sessions Trial No. 932 of 2025 arising out of Kumarbag P.S. Case No. 145 of 2025 pending in the court of learned District & Additional Sessions Judge-XI, Bettiah, District- West Champaran.

7. Prayer is refused.
