No. 10/2022 by which setting aside the order dated 12.09.2012 passed by the Commissioner, Purnea Division, Purnea in Land Dispute Appeal No. 144 of 2011. The learned Commissioner, by the impugned order, had rejected the appeal filed by the petitioner challenging the order dated 20.10.2011, passed by the Deputy Collector, Land Reforms, Banmankhi, Purnea in Land Dispute Case No. 38/ 2011-12 by which the prayer of the petitioner has been rejected on erroneous and malafide and confused ground without considering all relevant facts and circumstances of this case.”
