2 15-05-2026 Heard learned counsel for the petitioner and the State.

2. Petitioner apprehends arrest in a case registered for
the offences punishable under Sections 190(1), 118(2), 3(5) of
the Bharatiya Nyaya Sanhita and Section 27 of the Arms Act.

3. As per F.I.R., on the instigation of co-accused
Brjesh Sharma, co-accused Chunnu Panday and Ankit Pandey
fired pistol upon the informant as a result of which, he sustained
firearms injuries.

4. Learned counsel for the petitioner submits that
petitioner is innocent and has committed no offence. Petitioner
is not named in the F.I.R. and his name transpired during
investigation. Specific accusation of firing is against co-accused
Chunnu Panday and Ankit Pandey. Only material that has come



against petitioner is that he helped the accused persons in fleeing away. There is absolutely no allegation of any specific overt act against petitioner. Petitioner claims clean antecedent.

5. Learned A.P.P. for the State vehemently opposed the bail application.

6. Considering the nature of accusation and clean antecedent, this anticipatory bail is allowed and it is ordered that let the above named petitioner in the event of his arrest/surrender before the court below within a period of eight weeks from today, be enlarged on bail on furnishing bail-bond of Rs. 10,000/- (ten thousand) with two sureties of the like amount each to the satisfaction of Chief Judicial Magistrate, Aurangabad in connection with Aurangabad Town P. S. Case No. 750 of 2025, subject to condition as laid down under Section 482(2) of the Bharatiya Nagarik Suraksha Sanhita, 2023.
