Transparency in Land Acquisition,
Rehabilitation and Resettlement Act, 2013
for the land acquired by the respondent
authorities for construction of Ramjankari
Path Projeet NH No. 72;*

*(ii) for any other relief or reliefs for which

Hon'ble High Court.*



3. After some argument, learned counsel for the petitioners submit that they shall be approaching before the District Land Acquisition Officer, Saran (Chapra) for the redressal of the grievance.
