2. The present petition has been preferred for the
following relief/s:

Order directing/commanding the
Respondents to give employment to the land
loosers (petitioners) without any*



*discrimination to them as per resolution
and/or assurance/commitment of the
Respondents at the time of the acquisition of
the land in question”.*
