1. Affidavit of service filed on behalf of the petitioner is taken on record.
2. By the present writ petition the petitioner seeks direction upon the respondents to disburse the interest towards the delayed payment of gratuity and arrear pension amount at the rate of 18% per annum from the date of effect of ROPA 2019 till the date of actual payment.
3. The petitioner contends that he retired as a Head Teacher on 31st January, 2020 from 07 Sarkarpara Primary School, P.O. Panchgram, Dist. Murshidabad after rendering 33 years of service. The first pension payment order was issued on 16th January, 2020. The revised pension payment order as per ROPA 2019 was issued on 10th December, 2021. The remaining gratuity and arrear pension was paid to the petitioner

on 10th December, 2021. However, no interest was paid on the delayed payment of gratuity and arrear pension. Hence this writ petition.

4. Mr. Arun Khutia, learned advocate for the petitioner submits that the petitioner is entitled to revised gratuity and arrear pension under ROPA 2019 from 14th February, 2020. However, no interest has been paid on the revised gratuity and arrear amount. He seeks for appropriate orders.
5. Mr. Arun Kr. Saha, learned advocate for the State leaves the matter to the discretion of the Court.
6. The revised gratuity and arrear pension has been given effect to from 14th February, 2020 under ROPA 2019. The revised gratuity and arrear pension has been disbursed on 10th December, 2021. In view of the above, the petitioner is entitled to interest on the revised gratuity and arrear pension.
7. Accordingly, respondent no. 2, the Director of Pension, Provident Fund and Group Insurance, Government of West Bengal and respondent no. 3, the Treasury Officer, Lalbagh, P.O. & P.S. Lalbagh, Dist. Murshidabad are directed to disburse the interest at the rate of interest @ 8% per annum on the gratuity and arrear of pension in favour of the petitioner by way of the pensionary benefits from the date of effect of ROPA 2019 i.e. 14th February, 2020 till the actual date of payment. Such payment is to be made within

a period of eight weeks from the date of communication of this order.

8. Learned advocate for the petitioner is directed to communicate this order to respondent no. 2, the Director of Pension, Provident Fund and Group Insurance, Government of West Bengal and respondent no. 3, the Treasury Officer, Lalbagh, P.O. & P.S. Lalbagh, Dist. Murshidabad for necessary compliance.
9. With the aforesaid directions, the writ petition being **WPA 17974 of 2025** stands disposed of.
10. Since no affidavit is called for, the allegations made in the writ petition are deemed to have been denied.
11. Consequently, connected applications, if any, stand disposed of.
12. Interim orders, if any, stand vacated.
13. There shall be no order as to costs.
14. Urgent photostat certified copy of the order, if applied for, be given to the parties on compliance of all necessary legal formalities.
