1. This matter is appearing under the heading "*To be mentioned*".

(vii) The date of joining of petitioner no. 8, namely, Suraj Das will be “13th February, 2017” in place and stead of “20th April, 2017” in Santosh Kumar Ghosh Smriti F.P. School under Gaighata East Circle, District North 24 Parganas.
