1. Learned counsel for the petitioner submits that the Railway is proposing to construct a railway line and for that there is proposal to acquire the land belonging to the petitioner, to which, the petitioner has submitted multiple representations before the concerned Authority, however, according to the petitioner till date same have not been considered and decided. As such, the petitioner seeking a direction to the concerned respondent-authority to consider and decide their pending representations as per relevant law/rules.

2. Learned counsel for the SECR as well as the State Counsel submit that till today only survey is going on and so far as the proposal for acquisition is concerned, it is yet to be finalized. If any representation of the petitioners is pending, same will be decided as per applicable law/rules. Learned State Counsel further pointed out that after survey, the railways has already published a notification dated 24.05.2026 in the Dainik Bhaskar news paper in Raipur circle.
 3. Heard learned counsel for the parties.
 4. Considering facts of the case, submissions of counsel for the parties, the instant petition stands disposed of directing the petitioners to approach before the concerned Railway Authority in order to decide their representations.
