**IN CIVIL APPLICATIONS FOR DELAY CONDONATION**

1. Heard both sides.
2. The applicants are seeking condonation of delay, ranging from 1330 to 2470 days in preferring appeals. They are seeking condonation of delay for the reasons stated in the application. The material particulars are as follows:
