**PER COURT :**

Civil Applications No. 4935 fo 2026 and 4936 of 2026,  
seeking withdrawal of the amounts not on Board. Upon mentioning,  
taken on Board.

**DELAY AND LRS**

2. Applicants in CA / 4892 /2026 seek to condone delay of 4672 days in preferring the Appeal in setting aside the abatement and bringing the LRS of deceased appellant – Prabhu S/o Govind Kendre on record.

3. Applicants in CA / 4893 /2026 seek to condone delay of 186 days in preferring the Appeal in setting aside the abatement and bringing the LRS of deceased appellant – Babu S/o Govind Kendre on record.

4. The cause of action survives against the heirs of the deceased. No *mala fides* are noticed in preferring the appeal / s belatedly. Delay stands condoned. Abatement is set aside. Leave is granted to the parties to carry out the amendment. Civil Applications are disposed of.

**DELAY**

5. Applicants seek to condone delay ranging from 543 days.

6. Averments of the applications have not been controverted by the respondents. There is no reason to infer any oblique motive on the part of the Acquiring Body in preferring the appeal / s belatedly. Delay stands condoned. Civil Applications are disposed of.

**WITHDRAWAL**

7. Applicants seek withdrawal of various amounts deposited by the respondent – Acquiring Body.

8. Both the parties state that only 50% of the amount is deposited by the Acquiring Body. Ends of justice would be met by allowing the applicants to receive the amount deposited in this Court with accrued interest.

9. Civil Applications are allowed partly.

10. Applicants are permitted to withdraw the amounts deposited by the Acquiring Body, respectively, with accrued interest on furnishing undertaking to the satisfaction of the Registrar (Judicial) of this Court.

**STAY**

11. Learned counsel for the Acquiring Body seeks time to deposit the amount.

12. Time of 12 weeks is granted to deposit the amount.
