1. Heard the learned Advocate for the applicant. Issue notice to the respondents. The respective learned Advocates waive notice for the respective parties, for whom they are appearing in the appeal.

2. This is an application for restoration of the order passed by the learned Registrar (Judicial) in F.A.Stamp No.24624/2024 dated 2.11.2024, which was dismissed in default for non removal of office objections within stipulated period.

3. In view of the conditional order dated 12.11.2024 passed by the learned Registrar (Judicial) and for the reasons stated in the application, the application is allowed the delay stands condoned. F.A.Stamp No.24624/2024 stands restored to its original position and be kept for hearing alongwith all connected applications.
