PER COURT :-

1. Heard both sides.
2. Applicants seek to condone delay which is ranging from 71 to 4700 days delay in preferring first appeals.
3. Applications are contested by the respondents.

4. The averments of the applications have not been traversed. There is no reason to infer any malafides on the part of the applicants. Applicants are ready to give up interest and statutory benefits for the delayed period. The delay stands condoned on the condition that applicants shall not be entitled to interest and statutory benefits for the delayed period.

5. Civil applications for delay are allowed accordingly.

Civil Applications for Addition Evidence

6. Civil applications to produce addition evidence are not pressed as learned counsel does not pray for the same.

7. List all the first appeals in disposal category on 26.02.2026.

8. Applicants seek to condone delay of 968 days in setting aside abatement and bringing legal heirs of deceased claimant Babasaheb Punjaji Kharat on record.

9. The cause of action survives as against the legal heirs. They are necessary parties. The delay is unintentional. The

delay stands condoned, abatement is set aside and leave is granted to bring legal heirs of deceased claimant on record.

10. Civil application is allowed.

11. Both parties shall be at liberty to carry out necessary amendment.

12. Time is extended by three (3) weeks for service of notice in Civil Application No.14044 of 2024 at Serial No.75.
