. Applicants seek to condone delay of 122, 135, 118 and 136 days respective in preferring respective cross objections. The respondent – acquiring body has preferred the appeals which are yet to be decided and the pragmatic approach is to deal with cross objections on merits along with the appeals of the acquiring body.
