PER COURT :-**Civil Applications for Delay**

1. Applicant/acquiring body seeks to condone delay of 689 days in preferring first appeals.
2. For the reasons stated in the applications, delay stands condoned.
3. Civil applications for delay are allowed.

First Appeals

4. **Admit.**
5. Learned counsel Mr. Shinde waives service of notice for respondents/claimants.
6. Call for Record and Proceedings from the concerned Court.
7. Print is dispensed with.
8. All appeals shall be kept on 12.02.2026 along with group.

Civil Applications for Withdrawal

9. Applicants are praying withdrawal of amount deposited by the respondent/acquiring body. Appellants shall pay deficit

court fees by the next date. The enhancement is stated to be less than three times. In similarly situated matters, claimants are permitted to withdraw the amount on furnishing undertaking.

10. Applications are allowed partly permitting the applicants to receive the amount on furnishing undertaking to the satisfaction of the Registrar (Judicial).

Civil Applications for Stay

11. As the entire amount has been deposited in pursuance of the earlier order, ad-interim relief granted earlier shall stand confirm.

12. Civil applications are disposed of.
