**CIVIL APPLICATIONS FOR CONDONATION OF DELAY**

None appears for the contesting respondent, though served. Learned A.G.P. appears for respondent nos. 2 and 3.

2. The applicants seek to condone delay ranging from 14 to 5246 days in preferring the appeals. Following are the material particulars :

3. The learned counsel for the applicants submits that for the reasons stated in the applications, it is desirable to condone the delay, as the applicants are ready to give up interest and statutory benefits for the delayed period. It is further submitted that in appeal at Sr. No. 05 the delay is merely of 14 days and in the matter at Sr. No. 15 the delay is of 100 days for which the interest and statutory benefits be not forfeited.

4. The applications are contested by the respondents.

5. I find that the Acquiring Body has not caused appearance and contested the applications. The averments of the applications are not been traversed. I find no reason to infer any *mala fides* on the part of the applicants. The applicants are ready to give up interest and statutory benefits for the delayed period.

6. The delay stands condoned on condition that the applicants shall not be entitled to interest and statutory benefits for the delayed period. It is clarified that in the matter at Sr. No. 05 (Civil Application No. 12259/2025) and in the matter at Sr. No. 15 (Civil Application No. 12269/2025) there shall be no forfeiture of interest and statutory benefits for the delayed period, as the delay is very small.

7. Civil Applications are disposed of.
