ORDER :

- . Time of four (04) weeks is granted to take steps against the dead respondents as well as unserved respondents.
2. In case, fresh address is provided for the service of notice, then notice shall be issued, returnable after six (06) weeks.
3. In case for some technical reasons, the notices are unserved, re-issue notice to the unserved respondents, returnable six (06) weeks thereafter.
4. In case of remark of want of time, the time is extended by six (06) weeks.
5. Interim relief, granted earlier, if any, to continue till the next date.
6. Humdast/private service is permitted.
