PER COURT :-

1. By these applications, the applicants pray for restoration of appeals by setting aside the order dated 25/06/2024, passed by the learned Registrar (Judicial) of this Court, by which, registration of appeals was refused for non-removal of office objections in appeals within stipulated time. There is delay of 556 days in preferring these applications for restoration of appeals.
