PER COURT :-

. Applicant seeks withdrawal of amount of Rs.2,50,481/- deposited by the acquiring body. In similarly situated matters, this Court permitted the claimants to receive the deposited amount on certain conditions. I propose to follow the same course as is done in order dated 06.10.2025.

2. Civil Application is allowed partly permitting the applicant to receive 50% of the deposited amount with accrued interest on furnishing undertaking to the satisfaction of learned Registrar (Judicial) and remaining 25% of the deposited amount with accrued interest on furnishing solvent surety/security to the satisfaction of learned Registrar (Judicial) of this Court.

3. First Appeal No.3298 of 2025 shall be segregated from other matters because those are not from the same acquisition process.
