PER COURT :-

Civil Applications for Withdrawal

1. Heard both the sides.
2. Applicants seek to withdraw amount deposited by the respondent/acquiring body for the reasons stated in the applications.
3. In similarly situated matters, this Court already permitted the claimants to receive the amount. I propose to adopt the same course.
4. Civil applications for withdrawal are allowed by permitting the applicants to receive the amount with accrued interest on furnishing undertaking to the satisfaction of the Registrar (Judicial).

Civil Applications for Delay

5. Applicant/acquiring body has filed applications for condonation of delay in preferring respective first appeals.

6. Civil applications are not seriously disputed by the respondents.

7. There is no reason to infer any malafides on the part of the applicants. This Court has consistently been taken a view of condoning delay in similarly situated matters. The delay stands condoned.

8. Civil applications for delay are allowed.

First Appeals

9. Issue notice for final disposal to the respondents, returnable on 25.03.2026.

10. Learned counsel Mr. Shinde waives service of notice for respondents/claimants.

11. First appeals shall be decided finally at the admission stage on the next date.

Civil Applications for Stay

12. As the amount has been deposited in pursuance of the earlier orders, ad-interim relief granted earlier shall stand confirmed.

13. Civil applications for stay are disposed of.
