1. Heard.

9. The applicants are permitted to withdraw the amount of Rs.15,00,000/- deposited in this court along with accrued interest thereon in Writ Petition No.1704 of 2009. In terms of the list given by non-applicant no.1 Institute, Kisan @ Kisanrao Shankarrao (Shankar) Chandore is at Serial No.52. The civil application is allowed.
