1] The present Civil Applications are filed to permit the applicants to withdraw the amounts deposited by the appellant-NHAI.

2] The learned counsel for the appellants – NHAI submits that the appellant – NHAI intends to challenge the order passed by this Court in Arbitration Appeals before the Hon'ble Supreme Court.

3] The learned counsel for the applicants submits that all the Arbitration Appeals filed by the appellants–NHAI are already dismissed by this Court, as such, the applicants may be permitted to withdraw the amounts deposited by the appellants – NHAI in this Court. He further submits that the surnames of the applicants are not mentioned in some of the matters in Arbitration Awards as well as applications and appeals filed by the NHAI, therefore, the applicants may be permitted to withdraw the amounts as per the cause title of the civil applications filed by the applicants.

4] Considering the submissions, Civil Applications are allowed subject to furnishing an undertaking to this Court stating that in the event any favourable orders are passed in favour of the National Highways Authority, they will re-deposit the amount withdrawn within a period of four weeks. In case of discrepancy in names of the applicant, the withdrawal to be permitted only after satisfactory proof being submitted before Registrar [Judicial] that the person withdrawing the amount is the original claimant. The applicants are permitted to withdraw

the amounts as per the cause title of the Civil Applications filed by the applicants subject to verification as above. Civil Applications are disposed of accordingly.
