**PER COURT :-**

1. Civil applications are filed by the original claimants for withdrawal of the amount deposited by the National Highways Authority of India. Arbitration appeals filed by the NHAI are already dismissed by this Court by order dated 9.4.2026.
2. The learned advocate appearing for NHAI has filed reply to the applications filed for withdrawal of amount and strongly opposed the applications by submitting that the office of NHAI is intending to challenge the order dated 9.4.2026 passed by this Court and pray for

rejecting the applications for withdrawal of amount.

3. Since the applicants have succeeded in an applications under section 34, so also in appeals under section 37, the applications filed for withdrawal of amount are allowed and disposed of, subject to filing an undertaking that in the event any adverse order is passed by the Supreme Court, the applicants will deposit the withdrawn amount back to the Court within four weeks.
