2. Applicants seek to withdraw different amounts deposited by the respondent – Acquiring Body in the First Appeals.

3. The respondents were directed to deposit the entire amount with accrued interest while granting interim relief and entertaining the Appeal/s, however, 50% of the amount is deposited. As there are lapses on the part of the applicants, it is desirable to permit the applicants to receive the amount deposited by the respondent – Acquiring Body.

4. Civil Applications are allowed partly.

5. Applicants are permitted to withdraw the amount deposited by the respondent – Acquiring Body with accrued interest on furnishing undertaking to the satisfaction of the Registrar (Judicial) of this Court.
