Mr. Jagtap, learned Counsel appearing for Respondent Nos.1 to 6 in Writ Petition No.7800 of 2025 and Mr. Ingale, learned Counsel appearing for Respondent Nos.1 to 3 and 5 in Writ Petition No.11467 of 2025, state that a companion Petition, being Writ Petition No.1357 of 2026, has been filed by the Petitioner in Writ Petition No.7800 of 2025 before the Principal Bench of the Bombay High Court.
