In the said Affidavits, it has been stated that the Petitioners are not entitled to appear for examination of the Second Year B.A. LL.B Course, in view of the Petitioners having been declared as failed in the result of revaluation before the Petitions were filed by the Petitioners. The

provisional admission was accordingly cancelled. The Petitioners will therefore, have to take fresh admission for Second Year B.A. LL.B. for the academic year 2026-27.
