2. Heard. Ld. Advocate for the Plaintiffs submits that, the Writ of Summons sent for service upon the Defendant Nos. 4 to 87 through the Sheriff of Bombay could not be effected as the building of the Defendants where they reside is demolished. He, therefore,

prays that, the Plaintiffs be permitted to serve the Writ of Summons by way of substituted service.

3. Perused the affidavit in support. The Bailiff report dated 24th June, 2025 is at Exhibit “A” to the affidavit in support.

4. For the reasons mentioned in the affidavit in support the Chamber Order is allowed and the same is signed separately. Plaintiff to publish the Writ of Summons in two newspapers viz. “Free Press Journal” in English language and in “Navshakti” in vernacular language i.e. Marathi, as per schedule annexed to the Chamber Order within four weeks from the date of uploading this Order.
