By this Chamber Order the Applicant seeks permission to serve the citation upon (1) Sachin Vilas Kandade and (2) Samit Vilas Kandade, grandsons of the deceased (son of deceased nephew Machandranath Wamanrao Kandade), by way of substituted service as per schedule annexed to the Chamber Order.

2. Perused the schedule. The Applicant applies for publication of citation in two newspapers viz. “Free Press Journal” in English Language and in “Nav Shakti” in vernacular language i.e. Marathi, widely circulated in Mumbai.

3. Perused the affidavit in support. The Applicant has stated in the affidavit that, the citation sent for service upon (1) Sachin Vilas Kandade and (2) Samit Vilas Kandade, grandsons of the deceased (son of deceased nephew Machandranath Wamanrao Kandade) through the Sheriff of Bombay were returned with remark “unclaimed” “returned to sender”. It is further stated that, he had made enquiry with the relatives for the whereabouts of the said legal heirs of the deceased but did not get any information. The Applicant, therefore, requested to permit him to publish the citation

in two newspapers viz. “Free Press Journal” in English Language and in “Nav Shakti” in vernacular language i.e. Marathi, widely circulated in Mumbai.

4. Heard. Ld. Advocate for the Applicant submits that, the citation sent for service upon (1) Sachin Vilas Kandade and (2) Samit Vilas Kandade, grandsons of the deceased (son of deceased nephew Machandranath Wamanrao Kandade) through the Sheriff of Bombay were returned with remark “unclaimed” “returned to sender”. He further submits that, the Applicant had made enquiry with the relatives for the whereabouts of the said legal heirs of the deceased but did not get any information. He further submits that, the deceased died as issueless. He further submits that the citation sent for service upon abovenamed, legal heirs of the deceased was returned with postal remark and the bailiff of Sheriff of Bombay has filed affidavit of service dated 15th November 2025. He, therefore, prays that, the Chamber Order be allowed.

5. Perused para 11 of the Petition. For the reasons mentioned in the affidavit in support the Chamber Order is allowed. Applicant to publish the citation in two newspapers viz. “Free Press Journal” in English Language and in “Nav Shakti” in vernacular language i.e. Marathi, widely circulated in Mumbai, by way of substituted service of citation upon (1) Sachin Vilas Kandade and (2) Samit Vilas Kandade, grandsons of the deceased (son of deceased nephew Machandranath Wamanrao Kandade) of the deceased within four weeks from the date of uploading this Order. Applicant to file the affidavit of publication once the citation is published within two weeks thereafter.
