2. Testamentary Petition No. 516 of 2025 is not on board today. It

4. Dispute in the present Suit between the Plaintiff and Defendant has been settled. Plaintiff and Defendant has entered into Consent Terms dated 09.04.2026. Consent Terms are signed by Plaintiff Nos. 1 and 2, Defendant as also their respective Advocates. Parties executing the Consent Terms are present before this Court and have been identified by their respective Advocates. They confirm execution of the Consent Terms. 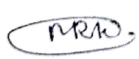

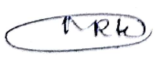
#### CONSENT TERMS

1. By consent of the Parties, Mr. Raizad Rusi Katrak is added as party Plaintiff No.2 to the present Suit. Amendment to the title of the Plaint be carried out during the course of the day.
2. The Plaintiffs and the Defendant hereto have settled their disputes and arrived at Consent Terms and agreed for distribution of the estate of the deceased late Hormazed Naval Davar on the terms and conditions mentioned in the present Consent Terms as follows: -
3. The Plaintiffs and the Defendant hereby withdraw all the allegations made by them against each other in their respective pleadings in the above matter and in the Interim Application

No.258 of 2026 and also agree and undertake before this Hon'ble Court not to raise in future any claim of any nature whatsoever with regard to the distribution of the estate of the deceased late Hormazed Naval Davar, against each other, in future.

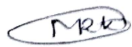
4. The Parties hereby agree and declare that the Defendant is the sole surviving legal heir of the deceased late Hormazed Naval Davar and therefore entitled to the entire estate of the deceased late Hormazed Naval Davar. The Defendant has accordingly filed a Testamentary Petition No. 516 of 2025 in the Hon'ble Court of Bombay for obtaining Letters of Administration of the property and credits of late Hormazed Naval Davar and the same is allowed by the Hon'ble Bombay High Court by an Order dated 07<sup>th</sup> April 2025. However, in view of the pendency of the present Suit the Letters of Administration is not issued to the Defendant. The Plaintiffs in view of the Consent Terms arrived herein, have no objection for issuance of the grant of Letters of Administration in favour of the Defendant in respect of the estate of the deceased late Hormazed Naval Davar and will not challenge the same or any ground in future under any circumstances.
5. The Defendant hereby agrees and undertakes to the Hon'ble Court to transfer 100% ownership right, title and interest of the deceased in respect of residential Flat No.C-2 in building Versova Silver View Co-operative Housing Society Ltd situated at 35, Jay Prakash Road, Andheri West, Bombay 400061 in favour of the Plaintiffs within three (3) weeks of grant and issuance of Letters of Administration of the estate of the deceased late Hormazed

Naval Davar in favour of the Defendant. The Defendant hereby agree and undertake to execute and register the Deed of Transfer in respect of Flat No.C-2 in favour of the Plaintiffs and also undertakes to sign and execute required writings/ documents/ forms/ undertaking in favour of the Plaintiffs in respect of transfer of the said Flat No.C-2 situate at Versova as stated above in favour of the Plaintiffs within three weeks of grant and issuance of Letters of Administration of the estate of the deceased late Hormazed Naval Davar. The Defendant shall get Share Certificate of the society in respect of the said Flat No.C-2, duly transferred in the name of the Plaintiffs by submitting necessary writings/ document to the society and shall pay all out of pocket expenses including stamp duty and registration charges thereof.

6. The Plaintiffs have filed Testamentary Petition No.5747 of 2024, which is now converted into Testamentary Suit No.151 of 2025. The Plaintiffs have now accepted the Defendant to be the sole legal heir in respect of estate of the Deceased and has therefore agreed not to pursue the said Testamentary Suit No.151 of 2025. The Plaintiffs therefore hereby withdraws the Testamentary Petition No.5747 of 2024 filed by her for Probate for Will dated 26<sup>th</sup> February 2024. In lieu of the Plaintiffs agreeing to not pursue the Testamentary Petition No.5747 of 2024 and Testamentary Suit No.151 of 2025 and agreeing to withdraw the same, the Defendant has agreed to do the following:

7. The Defendant hereby agree and undertake to pay to the Plaintiff No.2 a total sum of Rs.1,60,00,000/- (Rupees One Crore Sixty

lakhs only) towards full and final settlement of the claim of the Plaintiffs against the estate of the deceased of late Hormazed Naval Davar in the following manner: -

- (i) Rs.1,20,00,000/- (Rupees One Crore Twenty Lakhs Only) be paid on execution of this Consent Terms vide Demand Draft dated 06/04/2026 bearing No.075960 drawn on Standard Chartered Bank in favour of Mr. Raizad Rusi Katrak;
- (ii) The balance of Rs.40,00,000/- (Rupees Forty Lakhs Only) shall be paid by the Defendant within 2 weeks of grant and issuance of Letters of Administration of the estate of the deceased Late Hormazed Naval Davar in favour of the Plaintiff No.2 Mr. Raizad Katrak.

8. Save and except the said Flat No.C-2 at Versova as agreed herein above, the Plaintiffs hereby forthwith release, relinquish and surrender all their right, title and interest of any property of the estate of the deceased late Hormazed Naval Davar, if any, in favour of the Defendant in perpetuity. The Plaintiffs hereby agree and undertake not to raise in future any claim of whatsoever nature against the Defendant and/ or his heirs, successors, executors, or Trustees in respect of estate of the deceased late Hormazed Naval Davar or any other claim of whatsoever nature.

9. In view of the aforesaid settlement, the Testamentary Petition No.5747 of 2024 and Testamentary Suit No.151 of 2025 stands



disposed-off as withdrawn. The Plaintiff agrees and undertakes not to raise any claim of whatsoever nature on the basis of the alleged Will dated 26<sup>th</sup> February 2024 of late Hormazed Naval Davar.

10. The aforesaid statements and undertakings given hereunder are accepted by this Hon'ble Court. The above Petition stands disposed-off.
11. The Parties hereto and Learned Prothonotary and Senior Master, High Court, Bombay to act on authenticated copies of Minutes of the Order and Consent Terms and issue grant of Letters of Administration in favour of the Defendant.
12. Certified copy of the Order is expedited.

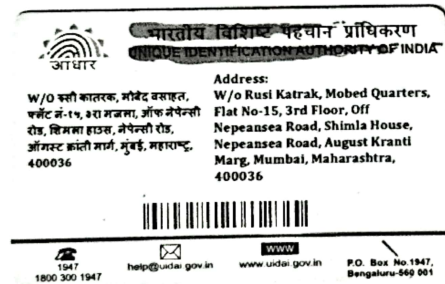
