1. This matter was kept back in the morning session, as the learned Senior Counsel and the learned Counsel for the parties sought some time to tender a draft minutes of order.

When the matter is called out in the afternoon session, Mr. Savant, learned Counsel appearing for the Plaintiff, Mr. Dwarkadas, learned Senior Counsel appearing for the Defendant No.1 and Mr. Kamat, learned Senior Counsel appearing for the Defendant No.2 tender across the bar a draft minutes of order dated 24th March 2026 identified by the Advocates on record, submitting that the Suit may be disposed of in terms of the draft minutes of order.
