- 2.** Heard Mrs. Nair, learned Advocate for Petitioner.
- 3.** Present Misc. Petition is filed by Petitioner for issuance of legal heirship certificate under Section 2 of Bombay Regulation VIII of 1827 in respect of the properties and credits of deceased Seeta Narayan Katgure alias Seeta Narayan Katkure alais Kaniz Fatima Mohamed Hanif Subhedar alias Kanis Mahmed Subhedar. The names and details of legal heirs of the deceased are stated in paragraph No.6 of the Petition. Purpose for filing the present Petition is stated in paragraph No.9 of the Petition. I have perused the same.

Sheikhmohammed Zafar Imam Subhedar alias Mohamed Hanif Subhedar being the only heir and legal representative of the said deceased under the provision of Bombay Regulation Act, Act, VIII of 1827.”

- 6.** Issuance of proclamation stands dispensed with.
- 7.** Department is directed to issue the legal heirship certificate as directed above within a period of 3 weeks from today positively.
- 8.** Misc. Petition is allowed and disposed subject to compliance of office objections, if any, forthwith which shall be allowed by the Department.
