By this Chamber Order the Applicant seeks permission to serve the citation upon (1) Jagdish Toparani, son of first wife of the husband of the deceased, (2) Harsha, (3) Meena, and (4) Hemu, daughters of the first wife of the husband of the deceased, by way of substituted service as per schedule annexed to the Chamber Order.

2. Perused the schedule. The Applicant applies for publication of citation in two newspapers viz. “Free Press Journal” in English Language and in “Maharashtra Times” in vernacular language i.e. Marathi, widely circulated in Mumbai.

3. Perused the affidavit in support. The Applicant has stated in the affidavit that, the Petitioner are not aware about the addresses of the deceased step children viz. (1) Jagdish Toparani, son of first wife of the husband of the deceased, (2) Harsha, (3) Meena, and (4) Hemu, daughters of the first wife of the husband of the deceased. The Applicant, therefore, requested to permit him to publish the citation in two newspapers viz. “Free Press Journal” in English Language and in “Maharashtra Times” in vernacular language i.e. Marathi, widely circulated in Mumbai.

4. Heard. Ld. Advocate for the Applicant submits that, the Petitioner are not aware about the addresses of the deceased step children viz. (1) Jagdish Toparani, son of first wife of the husband of the deceased, (2) Harsha, (3) Meena, and (4) Hemu, daughters of the first wife of the husband of the deceased. He further submits that, the deceased was married to Karsandas Madhavji Toparani who had predeceased the deceased and the deceased died as issueless. He further submits that, Shri Karasandas Madhavji Toparani had four children from his first marriage viz. (1) Jagdish Toparani, (2) Harsha, (3) Meena, and (4) Hemu. He further submits that, the Petitioners are not aware of the addresses of the above-named steps children of the deceased. He, therefore, prays that, the Chamber Order be allowed.

5. Perused para 11 of the Petition. For the reasons mentioned in the affidavit in support the Chamber Order is allowed. Applicant to publish the citation in two newspapers viz. "Free Press Journal" in English Language and in "Maharashtra Times" in vernacular language i.e. Marathi, widely circulated in Mumbai, by way of substituted service of citation upon (1) Jagdish Toparani, son of first wife of the husband of the deceased, (2) Harsha, (3) Meena, and (4) Hemu, daughters of first wife of the husband of the deceased within four weeks from the date of uploading this Order. Applicant to file the affidavit of publication once the citation is published within two weeks thereafter.

6. Registry is directed to issue fresh citation, if required.
