By this Chamber Order the Applicant seeks permission to serve the citation upon (1) Suvidha Motiram Mokal, Granddaughter of the deceased, (2) Amruta Pritam Patil alias Amruta Motiram Mokal, granddaughter of the deceased, (3) Shailesh Hariram Mokal, Grandson of the deceased, (4) Kalpesh Hariram Mokal, Grandson of the deceased, and (5) Atmaram Ganpat Mokal, Son of the deceased, by way of substituted service as per schedule annexed to the Chamber Order.

2. Perused the schedule. The Applicant applies for publication of citation in two newspapers viz. "Free Press Journal" in English Language and in "Navshakti" in vernacular language i.e. Marathi, widely circulated in Mumbai.

3. Perused the affidavit in support. The Applicant has stated in the affidavit that, the citation sent for service upon the legal heirs of the deceased were returned and affidavit of service filed by the bailiff of Sheriff of Bombay and filed affidavit of service by Bailiff of Sheriff of Bombay. It is further stated that, the Applicant is not aware of the heirs of the deceased and their whereabouts are

not known to the Applicant. The Applicant, therefore, requested to permit him to publish the citation in two newspapers viz. “Free Press Journal” in English Language and in “Navshakti” in vernacular language i.e. Marathi, widely circulated in Mumbai.

4. Heard. Ld. Advocate for the Applicant submits that, the citation sent for service upon the legal heirs of the deceased were returned and affidavit of service filed by the bailiff of Sheriff of Bombay and filed affidavit of service by Bailiff of Sheriff of Bombay. He further submits that, the Applicant is not aware of the heirs of the deceased and their whereabouts are not known to the Applicant. He further states that, the parents of the deceased and husband of the deceased and brother viz. Hariram Ganpat Mokal, predeceased the deceased and the Applicant is not aware of the present whereabouts of the legal heirs of the deceased. He, therefore, prays that, the Chamber Order be allowed.

5. Perused para 9 of the Petition. For the reasons mentioned in the affidavit in support the Chamber Order is allowed. Applicant to publish the citation in two newspapers viz. “Free Press Journal” in English Language and in “Navshakti” in vernacular language i.e. Marathi, widely circulated in Mumbai, by way of substituted service of citation upon (1) Suvidha Motiram Mokal, Granddaughter of the deceased, (2) Amruta Pritam Patil alias Amruta Motiram Mokal, granddaughter of the deceased, (3) Shailesh Hariram Mokal, Grandson of the deceased, (4) Kalpesh Hariram Mokal, Grandson of the deceased, and (5) Atmaram Ganpat Mokal, Son of the deceased, of the deceased within four weeks from the date of uploading this Order.
