By this Chamber Order, the Applicant seeks permission to serve the citation upon ALL CONCERNED, legal heirs of the deceased, by way of substituted service as per schedule annexed to the Chamber Order.

2. Perused the schedule. The Applicant applies for publication of citation in two newspapers viz. "Free Press Journal" in English Language and in "Mid Day" in vernacular language i.e. Gujarati, widely circulated in Mumbai.

3. Perused the affidavit in support and additional affidavit. The Applicant has stated in the affidavit that, the deceased died as issueless and the Applicant is not aware of the legal heirs of the deceased. It is stated in the additional affidavit that, the legal heirs of the deceased mentioned in the Petition are not known to the Applicant and their addresses are not known to the Applicant. It is further stated that, the Applicant had made inquiry with friends, neighbours and relatives about the addresses of the said legal heirs of the deceased but he could not get any whereabouts of the said legal heirs of the deceased. The Applicant, therefore, requested to

permit him to publish the citation in two newspapers viz. “Free Press Journal” in English Language and in “Mid Day” in vernacular language i.e. Gujarati, widely circulated in Mumbai.

4. Heard. Ld. Advocate for the Applicant submits that, the deceased died as issueless and the Applicant is not aware of the legal heirs of the deceased. He further submits that, the legal heirs of the deceased mentioned in the Petition are not known to the Applicant and their addresses are not known to the Applicant. He further submits that, the Applicant had made inquiry with friends, neighbours and relatives about the addresses of the said legal heirs of the deceased but he could not get any whereabouts of the said legal heirs of the deceased. He, therefore, prays that, the Chamber Order be allowed.

5. Perused para 8 of the Petition. For the reasons mentioned in the affidavit in support the Chamber Order is allowed. Applicant to publish the citation in two newspapers viz. “Free Press Journal” in English Language and in “Mid Day” in vernacular language i.e. Gujarati, widely circulated in Mumbai, by way of substituted service of citation upon ALL CONCERNED, legal heirs of the deceased within four weeks from the date of uploading this Order. Applicant to file the affidavit of publication once the citation is published within two weeks thereafter.

6. Registry is directed to issue fresh citation, if required.
