By this Chamber Order the Applicant seeks permission to serve the citation upon ALL CONCERNED legal heirs of the deceased and Kamladevi Bhatia, mother of the deceased by way of substituted service as per schedule annexed to the Chamber Order.

2. Perused the schedule. The Applicant applies for publication of citation in two newspapers viz. "Free Press Journal" in English Language and in "Navshakti" in vernacular language i.e. Marathi, widely circulated in Mumbai.

3. Perused the affidavit in support. The Applicant has stated in the affidavit that, the wife of the deceased had predeceased the deceased and the deceased had no legal heirs apart from the adopted daughter i.e. Petitioner and the details of his mother is not known to the Petitioner. It is further stated that, the mother of the deceased permanently settled elsewhere and her whereabouts is not known to the Petitioner. It is further stated that, the Applicant had made diligent search for getting address of heirs and relatives but none have been found. The Applicant, therefore, requested to permit him to publish the citation in two newspapers

viz. “Free Press Journal” in English Language and in “Navshakti” in vernacular language i.e. Marathi, widely circulated in Mumbai.

4. Heard. Ld. Advocate for the Applicant submits that, the wife of the deceased had predeceased the deceased and the deceased had no legal heirs apart from the adopted daughter i.e. Petitioner and the details of his mother is not known to the Petitioner. She further submits that, the mother of the deceased permanently settled elsewhere and her whereabouts is not known to the Petitioner. She further submits that, the Applicant had made diligent search for getting address of heirs and relatives but none have been found. She, therefore, prays that, the Chamber Order be allowed.

5. Perused para 4 (a) of the Petition. For the reasons mentioned in the affidavit in support the Chamber Order is allowed. Applicant to publish the citation in two newspapers viz. “Free Press Journal” in English Language and in “Navshakti” in vernacular language i.e. Marathi, widely circulated in Mumbai, by way of substituted service of citation upon ALL CONCERNED legal heirs of the deceased and Kamladevi Bhatia, Mother of the deceased, within four weeks from the date of uploading this Order. Applicant to file the affidavit of publication once the citation is published within two weeks thereafter.

6. Registry is directed to issue fresh citation, if required.
