By this Chamber Order, the Applicant seeks permission to serve the citation upon (1) Dimple Parag Shah, Daughter-in-law of the deceased, (2) Karan Parag Shah, and (3) Mehaan Parag Shah, Grandsons of the deceased, by way of substituted service as per schedule annexed to the Chamber Order.

2. Perused the schedule. The Applicant applies for publication of citation in two newspapers viz. "Free Press Journal" in English Language and in "Janmbhoomi" in vernacular language i.e. Gujarati, widely circulated in Mumbai.

3. Perused the affidavit in support. The Applicant has stated in the affidavit that, son of the deceased predeceased the deceased. It is further stated that, the deceased died on 14th March, 2025, the Petitioner /Applicant is not aware about the whereabouts of the Dimple Parag Shah, being Daughter-in-law, Karan Parag Shah and Mehaan Parag Shah, grandsons of the deceased. It is further stated that, the citation were sent for service upon abovenamed legal heirs of the deceased through the Sheriff of Bombay has been returned with remarks "Addressee Left without instructions". Applicant to file the affidavit of publication once the citation is published within two weeks thereafter.
