P.C.:

1) The Interim Application is filed seeking restoration of Application filed under Section 11 of the Arbitration and Conciliation Act, 1996, which is disposed of on 17 April 2025.

2) It is submitted on behalf of the Applicant that Arbitration Application was withdrawn on account of settlement of loan Account. However, on disposal of the Arbitration Application, the Respondent has once against committed default in payment of loan. It appears that no liberty was granted while disposing of Arbitration Application vide order dated 17 April 2025.

3) The Respondent is served with private notice in the Interim Application but has failed to appear before the Court. For the limited purpose of grant of liberty for filing of fresh Section 11 Application, order dated 17 April 2025 is recalled and the Arbitration Application is restored.
