Heard the learned Counsel for the applicant, the learned Counsel for non-applicant No.1, and the learned A.G.P. for non-applicant Nos.2 and 3.

02. By the present application filed under Section 5 of the Limitation Act, 1963, the applicant-acquiring body seeks condonation of delay of 5 days caused while lodging the appeal against the judgment and award dated 25/10/2023 passed in Case No.1471/AMT/AMT/2020 by the learned Presiding Officer, Land Acquisition, Resettlement and Rehabilitation Authority, Nagpur.

03. The learned Counsel appearing for non-applicant No.1 has not seriously objected to the condonation of delay of 5 days. The learned A.G.P. submits that suitable order may be passed.

04. For the reasons and explanation offered in the application, the delay of 5 days caused while lodging the appeal is hereby condoned.

05. In the meantime, the appellant shall file private paper-book.
