JUDGMENT

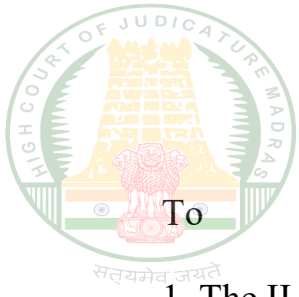
Today, this second appeal is restored to file, as per the order passed by this court in CMP No.6888 of 2026.
