4. No prejudice will be caused to the official respondents, if the aforesaid representation of the petitioner is considered, on merits and in accordance with law, after hearing objections from the fourth respondent as well as any other party whom the official respondents deem fit to enquire, within a time frame to be fixed by this Court. Accordingly, this writ petition is disposed of by



directing the second respondent to pass final orders on the petitioner's representation dated 02.11.2025 seeking for cancellation of patta standing in the name of the fourth respondent for the subject property, after hearing objections from the fourth respondent as well as any other party whom the second respondent deems fit to enquire, within a period of 12 weeks from the date of receipt of a copy of this order.
