Writ petition is filed under Article 226 of the Constitution of India, seeking for issuance of a writ of mandamus to direct the respondents 1 to 4 to consider the petitioner's representation dated 14.10.2025 and to cancel the patta granted in favour of the respondents 5 to 13 viz.,patta No.1800 in the name of respondents 5 to 8 in respective S.No.282/5 in Madura Kondaingi village, Villupuram Taluk for an extent of 4.3 ares; patta No.365 in the name of 7th



respondent in respective S.No.11/3 in Madura Kondaigi village, Villupuram Taluk for an extent of 1.90 Ares; patta No.250 in the name of respondents 9 and 10 in respective S.No.286/1A in Madura Kondaingi village, Villupuram Taluk for an extent of 1.50 Ares; Patta No.327 in the name of respondents 10 and 11 in respective S.No.286/1B in Maudra Kondaingi village, Villupuram Taluk for an extent of 1.50 Ares; Patta No.1748 in the name of 10th respondent in respect of S.No.286/1C1 in Maudra Kondaingi village, Villupuram Taluk for an extent of 8.13 Ares; Patta No.1436 in the name of respondents 5,10,12 and 13 in respective S.No.286/1C2 in Maudra Kondaingi village, Villupuram Taluk for an extent of 11.24 Ares; and Patta No.1748 in the name of 10th respondent in respect of S.No.286/1C3 in Maudra Kondaingi village, Villupuram Taluk for an extent of 11.3 Ares; and pass such further orders.

ORDER

This writ petition has been filed seeking for a direction to the respondents 1 to 4 to consider the petitioner's representation dated 14.10.2025 requesting to cancel the pattas granted in favour of the respondents 5 to 13 for their respective properties morefully described in the prayer to this writ petition.

2. The petitioner claims that erroneously, the fourth respondent has issued pattas in favour of the private respondents. The petitioner had submitted a representation dated 14.10.2025 requesting the official respondents to cancel the



pattas granted in favour of the private respondents. Since the said representation has not been considered till date, the petitioner has filed this writ petition.

3. Mr.S.Arumugam, learned Government Advocate, accepts notice on behalf of the official respondents. Since no adverse orders are passed against the respondents 5 to 13 in this writ petition, notice to them in this writ petition is dispensed with.

4. No prejudice will be caused to the official respondents, if the aforesaid representation of the petitioner is considered, on merits and in accordance with law, after hearing objections from the respondents 5 to 13 as well as any other party whom the official respondents deem fit to enquire, within a time frame to be fixed by this Court. Accordingly, this writ petition is disposed of by directing the third respondent to pass final orders on the petitioner's representation dated 14.10.2025 seeking for cancellation of pattas granted in favour of the respondents 5 to 13 for the subject property, after hearing objections if any from the respondents 5 to 13 as well as any other party whom the third respondent deems fit to enquire, within a period of four months from the date of receipt of a copy of this order.
