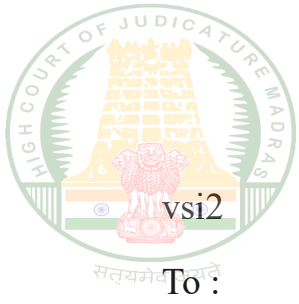
No costs. Consequently, connected miscellaneous petition is closed.
