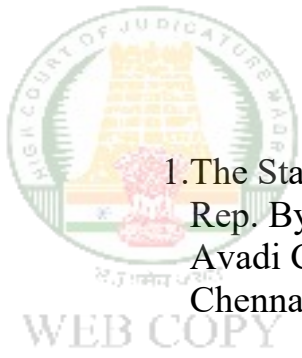

COMMON ORDER

Though it is claimed by the petitioner in Crl.O.P.No.3731 of 2026 that the matter has been amicably settled, the learned counsel appearing for the petitioner in Crl.O.P.No.3716 of 2026 submitted that the matter has not been compromised. He further submitted that though the accused has agreed to settle the matter, he has failed to pay the amount, as agreed. For the said reason, the petition has been filed seeking a direction to complete the investigation.

5. In view of the above submissions, Crl.O.P.No.3731 of 2026 stands dismissed and Crl.O.P.No.3716 of 2026 stands allowed, with a direction to the respondent to complete the investigation and file the final report within a period of four months from the date of receipt of a copy of this order.
