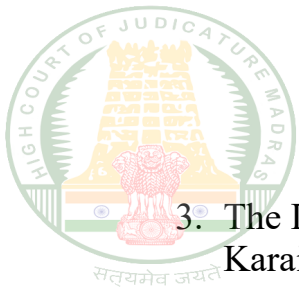

W.P.No.1727 of 2022: Writ Petition is filed under Article 226 of Constitution of India, seeking to issue a Writ of Mandamus directing the Respondents 1& 2 to take action against the respondent 5 for running Vinodh Liquors from 2018 to 2021 in violation of Puducherry Excise Rules 1970 and without the petitioners' authority and recover the amount illegally earned by the 5th respondent all through these years and pass such further or other orders.

W.P.No.1927 of 2022: Writ Petition is filed under Article 226 of Constitution of India, seeking to issue a Writ of Mandamus directing the Respondents to give consent/approval to the request by the license holders of Vinodh Liquors for shifting its premises from RS No.81/3A Nagore Main Road, Kheezha Vanjore, Karaikkal to No.226, Polagam, Nagore Main Road, Karaikkal within the time frame as may be fixed by this Court.

W.P.No.7831 of 2022: Writ Petition is filed under Article 226 of Constitution of India, seeking to issue a Writ of Mandamus directing the Respondent No 1 to number the second appeal filed under section 60(3) of the Puducherry Excise Act 1970 by the petitioners herein on 14.6.2021 against the order dated 18.3.2021 in Appeal No. 35 of 2020 passed by Respondent No. 2 and decide the case on merits within the time frame as may be fixed this Honble High Court

COMMON ORDER

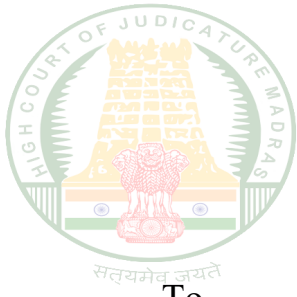
