PRAYER: Writ petition is filed under Article 226 of the Constitution of India, pleaded to issue a Writ of Mandamus, directing the 2nd respondent / The District Collector(Revenue) to consider the petitioners representation dated 02.02.2019, 16.06.2025 and 07.11.2025 to re-determine the compensation awarded to the petitioner for his lands in R.S. No.7/8D measuring and extent of 0.26.50 ares acquired at Karasur Revenue Village in Award No.2/2008 to a sum of Rs.21,261/- per are, pursuant to the enhanced compensation award dated 01.12.2018 passed in LAOP No.110 of 2012 on the file of II Additional District Judge, Puducherry.
