3. The challenge in the writ petition is to the sale notice. It is brought to the notice of this court by learned counsel for the respondent that the sale is concluded and the writ petition has become infructuous.

4. Therefore, nothing survives for further adjudication in the matter. Accordingly, the writ petition is dismissed. There shall be no order as to costs. The connected miscellaneous petitions are closed.
