When the matter was taken up for hearing, the learned Additional Public Prosecutor appearing for the 1st respondent submitted that though the petitioner has come up with the present criminal original petition seeking to quash the proceedings in C.C.No.264 of 2025, pending on the file of the learned Judicial Magistrate No-I, Ponneri, the case now stands posted to 16.02.2026 for commencement of trial.

2. At this juncture, the learned counsel for the petitioner sought permission of this Court to withdraw this criminal original petition. An endorsement as regards withdrawal was also made by the learned counsel for the petitioner in this petition today. However, he sought the indulgence of this Court to dispense with the personal appearance of the petitioner before the trial court.

3. In view of the above, this criminal original petition stands dismissed as withdrawn. However, acceding to the submission made by the learned counsel for the petitioner, the presence of the petitioner before the trial court is dispensed with, except for receipt of copies, answering the charges, questioning under Section 313 of Cr.P.C. However, it is made clear
