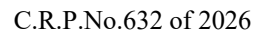

Taking into consideration the turn of events, the petitioners are directed to represent plaint offering their explanation for the defects pointed out by the Trial Court in the return dated 09.12.2025, within a period of two weeks from the date of uploading of this order. If the Trial Court is satisfied with the explanation offered by the petitioners, the same shall be numbered and proceeded with in accordance with law. If the Trial Court is not satisfied with the explanation offered by the petitioners, the matter shall be called in open Court and the petitioners shall be afforded with an opportunity to putforth their case on merits. Thereafter, the order shall be passed by the Trial Court on merit with regard to the maintainability of the plaint.

5. With the above directions, the Civil Revision Petition stands disposed of. No costs.
