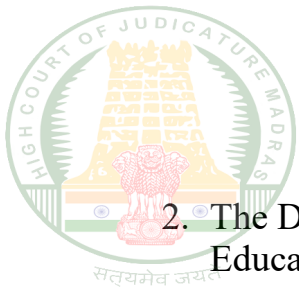

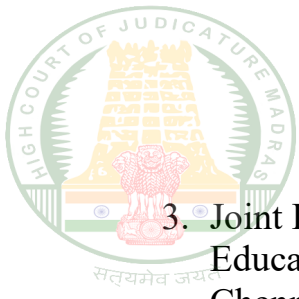

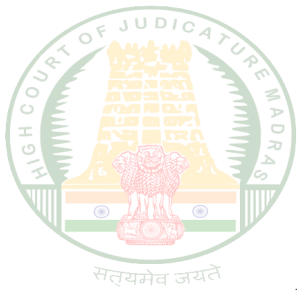

COMMON ORDER

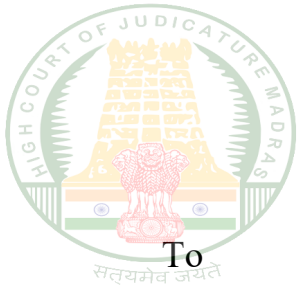
Learned counsel for the petitioners submitted that the cause in the writ petitions does not survive for consideration and thus, the writ petitions have become infructuous.
