For the foregoing reasons, this Court directs the 3rd respondent to pass final orders on merits and in accordance with law, on the petitioner's representation, dated 21.01.2020 seeking for cancellation of patta standing in the name of the 5th respondent for the property morefully described in the prayer to this writ petition, within a period of twelve (12) weeks from the date of receipt of a copy of this order, after hearing the objections of the 5th respondent, and any other third party, whom the 2nd respondent deems it fit to enquire and after giving due consideration to the supporting documents filed by the respective parties.
